No 1 - Walnut tree dangerously leaning towards the oil tank, bearing in mine the increasing strong winds we are seeking permission to reduce the weight by removing the overhanging branches. The trunk of the Walnut tree is 325cm from the oil tank and is 30cm from the log store / tree house.
No 2 - Old apple tree 100cm from the cottage, bearing in mind the the higher temperatures and the risk of subsidence we are seeking permission to remove the apple tree. The trunk of the Apple tree is 340cm from the boundary fence and 470cm form the house next door, "Calagone"
