Seeking consent for following works as part of Charnocks Close House Owners Association Limited (CCHOA) proposed 3-5 year management plan for all trees on the Green. All works were discussed with Tree Officer, Adrian Sargeant, at a site meeting on 22nd September 2023:

PHASE 1:

TO10 -TO15 (Limes)\* - to improve amenity value for and reduce shading to adjacent Stocks Lane properties:

Remove all epicormic growth, and crown lift by 3-4 metres.

Crown reduce by 3-5 metres to previous pruning points where

applicable, and as suggested by Tree Officer.

Remove TO12 ("suppressed and of little amenity value"). Replace with alternative species at distance from existing location on Green.

\* Refer TPO 0008 (1998)

#### PHASE 2:

Remove all epicormic growth and crown lift all trees by 3-4 metres where applicable to facilitate access for grass cutting machinery. TO36 (Crimson Norway Maple) - Remove/reduce branches that overhang road on southern aspect.

TO29 (Sycamore) - Remove accumulation of deadwood. Anticipated that further professional advice will be sought regarding possibility of Sooty Bark Disease (and additional consent for tree removal sought if necessary).

#### PHASE 3:

TO33 (Sweet Chestnut) - Crown reduce as much as possible (by maximum of 30%), shape and remove ivy growth.

TO34 (London Plane) - Crown reduce as much as possible (by maximum of 30%), shape and remove/reduce branches that overhang road on western aspect to give a clearance of 4 metres.

TO35 (Lime) - Crown reduce as much as possible (by maximum of 30%), shape and thin.

PHASE 4:

TO20 (Ash) - Crown reduce as much as possible (by maximum of 30%), and remove branches overhanging rear garden of no.12 Charnocks Close to give clearance of 3-4 metres.

TO26 (Norway Maple), TO27 (Norway Maple) and TO28 (Cherry) - Crown reduce as much as possible (by maximum of 30%), thin and remove branch

overhangs where required to reduce congestion.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
