I would like to cut back the Sycamore tree in TPO ref: TPO1995\_011 label G1. This is a line of 3 trees of which two of them have already been cut down completely and it's the last one in the row which backs up to Hill Rise Avenue that I would like to cut back. I have arrowed where it is on the scetch. I have spoken with a tree surgeon and he recommended to ask for a 30% reduction. This tree is not on my land but mainly covers my land and I have spoken with the owners of the tree and they are okay with me cutting it back. Reason I'm requesting for the tree to be cut back is that it covers my whole back garden and is starting to come over the top of my house. I'm not concerned that the tree is going to fall over at the moment however it is only growing towards my house and has no crown at the other side so maybe an issue down the line. Thanks.
