Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

There is a large Ash tree on the corner of our playground which overhangs the main school building and also Asquith Avenue. This tree presents significant issues with regards to dropping in the Autumn and fills our drains with leaves/pods which require constant removal and end up all over school. We have a very old building which suffers from old narrow drains which cannot cope with this level of debris. We have been advised by our arborculturist that the tree will die in the next few years and is already showing signs of this. We are very concerned that during high winds this tree could potentially either lose a heavy branch or fall altogether onto either the playground or Asquith Avenue which could present a danger to life. If the tree fell and landed on the school buildings this could potentially close the school. Crown reduction has been carried out, however, this does not resolve the issue.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
