- T1 To sectionally fell to ground level Damson tree by side of house in rear garden showing signs of decline in upper crown and major cavities throughout crown and stem client wishes to plant a native tree elsewhere away from house in garden to replace
- T2 To sectionally fell to ground level Lime tree in rear garden due to future landscaping works and allowing the 2 sycamore trees behind to become more dominant client wishes to plant a native tree elsewhere in garden to replace this to fit in with the new landscaping design T3 & T4 To crown reduce 2 Sycamore trees by 2.5 metres in height and 1 metre in lateral spread and remove ivy from right hand tree in rear garden so both trees form one crown shape
- T5 & T6 To crown reduce 2 Holm Oak trees by 1.5 metres in both height and lateral spread next to driveway to gain a more architectural shape and approve the amenity value of the trees
- T7, T8 & T9 To crown reduce a row of 1 Sycamore and 2 Holm Oak trees at front of property to a similar height to form a level screen T10 To crown lift one branch from Sycamore tree to a height of 5 metres away from property
