The said Tree Large Tall (AshFraxinus excelsior) , approximatly 22 meters High (Measured with Impulse Laser) Has Basal Root and signs of Ash Die back in the Canopy of the tree.

The said tree can not recover and the base has decay and is within falling distance to the Property.

Clar fell the said tree down the bank into the woodland area, De-limb / Sned the branches and create a Habitat piles and leave the Stem in situ . Not possible to get machinery into the area without cutting other trees down to make a clear path.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
