T1 - Oak - 19m height, 10m spread: Crown reduction as part of on going maintenance to ensure trees remain proportionate to house and light levels are not excessively restricted, height to be brought down by approximately 3m and overall spread reduced to 8m. Also to raise canopy to approximately 4m to allow passage of vehicles and clearance over pavement, 1m clearance of street light.

T3 - Oak - 16m height, 7m spread: crown lift to 4m to allow passage of vehicles, 1m clearance from buildings.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
