The excavation of 3 wildlife ponds to encourage natural breeding of Great Crested Newt in the area, delivered by Natural England's scheme of District Level Licensing. Pond GCN1 measures 400M2, Pond GCN2 at 500M2 and Pond GCN3 at 400M2. These will be adjacent to the existing dragonfly pond which holds water all year round, a nature trail footpath will be signposted for the public to enjoy the wildlife ponds.

An existing 6.5 acre area of permanent pasture belonging to SBBO has been chosen for the location of 3 medium sized breeding ponds for Great Crested Newts, a European Protected Species (a maximum of 500m2). The site comes within both the core and fringe (GCNs moving from pond to pond) Strategic Opportunity Area identified by Natural England as part of the Great Crested Newt District Level Licensing scheme. This scheme is to effectively connect GCN populations impacted by high levels of development and is aimed at increasing GCN numbers and improving habitat.
