Identification of Tree(s) and Description of Works

The beech Hedge between The Courtyard, and Sevenoaks on Waverley Avenue is long established and trimmed regularly. The exception to this is a branch at the far end (from the road) which was too big to trim when current owners moved in (2016), and is now overhanging the Garage of 'Sevenoaks'. The owners of Sevenoaks have asked if we can remove this branch (now a tree?) to reinstate the hedge line. The branch does not seem diseased or dangerous at the moment, but could become so.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
