## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Seeking permission to remove two (2) trees from the rear garden of 36 Davenport Avenue, Hessle. The first tree is an extremely large conifer at the north east of the garden and is marked C1 on the plan. It is the furthest tree from the house on the photograph. This not only blocks light from neighbouring garden but is now causing subsidence to their garage which it stands adjacent to. They have asked that it be removed. The second tree we are seeking to remove is a large Yew, marked Y1 on the plan and is the nearest tree to the house in the photograph. This stands very close to the rear of our house and the roots are invading into the drainage system causing us to have several recent blockages.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
