T1 Sorbus tree, nearest to house, Prune to contain shape approx. 0.5-1m reduction all round. T2Grafted Maple in center of garden, reduce crown by 1-1.5 metres all round.
T3 & T4 Apple and Pear, thin crowns by 10% and reduce by approx. 1-1.5 metres.
T5 Birch tree ,nearest to house, remove all major deadwood and reduce the crown by 1-2 metres.
