Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Blue Atlas Cedar - Fell to approx. 1m stump.

Reason - The Cedar tree is growing close to the property (Number 3) and to the neighbouring property (Number 5). It is a huge tree for the size of the garden and hard to maintain at a manageable size.

There are many other trees in the garden. There is a Garrya Elliptica growing beneath the tree that would benefit from its removal. The owner also plans on replacing the Cedar tree.

The roots are disturbing the adjacent ground and patio.

The neighbour also has allergies to the trees pollen. (Please see statement below provided by the neighbour regarding the tree)
In addition to the size and root issues the neighbours have reminded us that the pollen from the tree is causing allergies and the needle drop is a nuisance, the following message from them supports this.

"We appreciate that it's a beautiful, mature tree and that the owners are likely to be reluctant to remove it completely.

However, I think you have to live with the tree to really appreciate all of the issues that come with it and we'd like to explain some of these to you:

- It creates an expansive dry canopy over our garden which means we have to work hard throughout the spring and summer to keep constantly watered
- It shreds pine needles throughout the year, particularly late summer, and this affects our soil and covers all of our garden surfaces, including the patio up to the house
- An enormous dump of fir cones throughout Autumn thickly carpets everything under its canopy. We have to painstakingly pick these out of our beds and lawn to keep them in the condition we want. The shear amount of debris this creates can't be understated. I've included photos from last weekend which is only a fraction of what we've already collected and what is yet to come down.
- On dry days it gives off thick visible clouds of green pollen which coats our patio, windows and has ruined the washing on our clothes line a number of times. I suspect it's also a contributor to my hayfever being particularly bad in recent years and also our children suffering.
- It has a detrimental affect on most of the plants which we try to grow beneath it, which also happens to be in the sunniest part of our garden which we like to make use of.

All of the tenants that have lived next door to us, including the current ones, have also complained to us about the tree. Partly for the same experiences as us with regards to debris and pollen, but also from the darkness it recreates over their home and garden."
