- T1 Oak, mature. crown reduction, approximately 30% Reduce by 3 meters from height, 4 meter spread. targeting natural pruning points. Reduce back from neighbouring property.
- T2 Oak, mature. Crown reduction. Approximately 30% targeting natural pruning points. Reduce by 3 meters from height, 4 meter spread.
- T3 Oak, suppressed by larger Oak. Part reduction. Rebalance by reducing lateral branches by 3 meters. Targeting natural pruning points.
- G1 3 small Sycamore stems. Reduce height by approximately 3 metres
- G2 small self seeded Oak stems. Reduce height by approximately 3 metres.
