### Description

Please describe details of the proposed development or works including any change of use

The proposed works is for the installation of a ground mounted solar PV system and ancillary equipment (inverters and battery storage). It will generate 20kWp of clean net zero carbon electricity for our home and small holiday letting business, which consists of 2 barn conversions. The proposed system comprises of 2 row of 24 panels (48 panels in total), and they are located on a seasonably adjustable ground-mounted metal frame. The panels will be installed in landscape orientation to minimise any visual impact. The proposed system will not be visible from anywhere other than our home and holiday accommodation units (our target customers are eco-conscious). The land on which the PV array will be sited will continue to be used for agricultural purposes, as it currently is, with no change of use whatsoever. The low profile and slope of the ground and adjacent hedges will ensure that they also blend in to the surrounding existing wildlife areas. No existing hedgerows will be altered. New surrounding hedges will be planted to provide sufficient screening. Our current annual electrical usage is upwards of 10,000kWh and this proposed PV system will provide an estimated 25,000kWh per annum of clean net zero carbon generated electricity, and should meet our needs for future growth as we add EV charging for our customers. This will also represent a CO2 saving of 6,600kg/year together with a level of over 74.6% self-sufficiency.
