See sketch. There is a rowan about 5-6m tall, planted by us about 8 years ago alongside a crabapple, a quince and a magnolia. The rowan sadly died in the drought in June 2023. We wish to cut the dead tree down and replace it
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
