Photograph of the Chestnut Tree. The tree has grown very tall and in a recent storm one of the branches fell. As a precaution, we would like to pollard the tree to reduce chances of further branches falling.
Norway Spruce - this has also grown very tall and is posing a danger to near by houses. Unfortunately the leaves are showing signs of dying and as a precaution, we would like to pollard the tree to help encourage new growth and for it to be safe for our neighbours.
Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We have a large Chestnut Tree that is over 120 years old. It is very tall and the branches are well spread. Some of the branches spread over Old Monmouth Road, some near to Coglan Cottage, some near Coglan Lodge and some spread over our garden and drive. Recently one of the branches fell in the high winds of early January.

Beside the Chestnut Tree is a tall Norway Spruce tree. We would also like to prune the Norway Spruce, so as to reduce risk of its branches falling and damaging near by properties, including Coglan Lodge, Bank Cottage and Baden House

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
