The proposed works are to Crown reduce the tree by approximately 30%. This will mean reducing the new growth by approximately 5ft around the whole canopy. The pruning cuts will be made to new growth points to promote natural form following future growth.

All works will be carried out according to BS3998 Tree Works Recommendations.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
