7/1984 - T1 fell tree down to ground level and remove from site as it is infected with Ganoderma applanatum/australe.

Replanting will be in line with council/parish requirements and under advice from Rylands as to appropriate species.

This was identified when previous works were advertised to neighbours, and the fungus was brought to our attention. We checked with Ryland Horticulture, who confirmed the type of fungus and its long-term impact. (Information attached as part of the application.) Whilst we have been advised that this is unlikely to cause issues in the short term, the Tree would be a hazard to the road and pavement which is very close.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
