Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Willow tree situated in the front drive of residential property, adjacent to the boundary fence in the front garden. Branches overhang public footpath and road.

During windy and breezy weather conditions, branches are breaking off and falling onto the public highways, causing obstructions.

I would like to request the necessary permission to reduce the trunk height of the tree by 3 metres, which would solve the overhang of branches we experience at this time.

We previously had planning permission from Fenland Council in 2017- Reference: F/YR17/0367/TRTPO and we undertook the work with a reputable tree surgeon. However, since the work was done, the tree has grown a significant amount and has again become unmanageable. We would also like to request

that any permission, if granted, will specify that, we are allowed to carry out regular maintenance, to keep the tree under control, so that we do not have to keep re-applying to Fenland.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Sketch plan requirements

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
