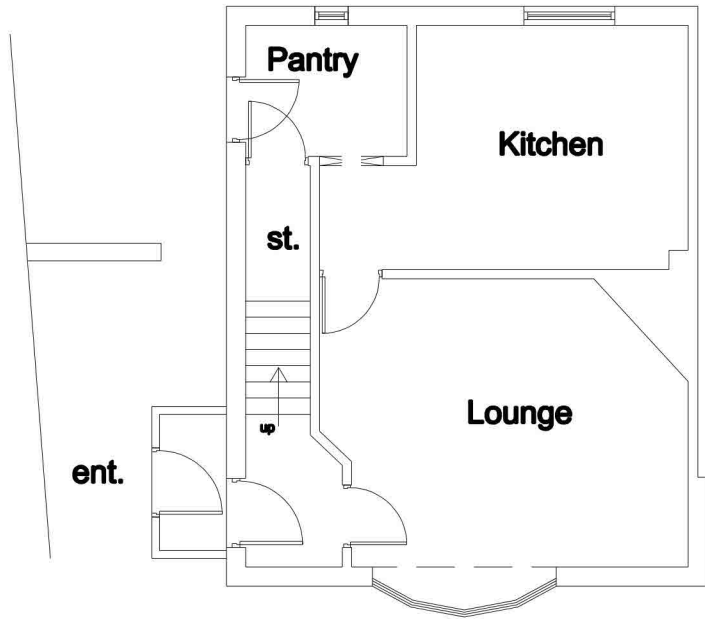
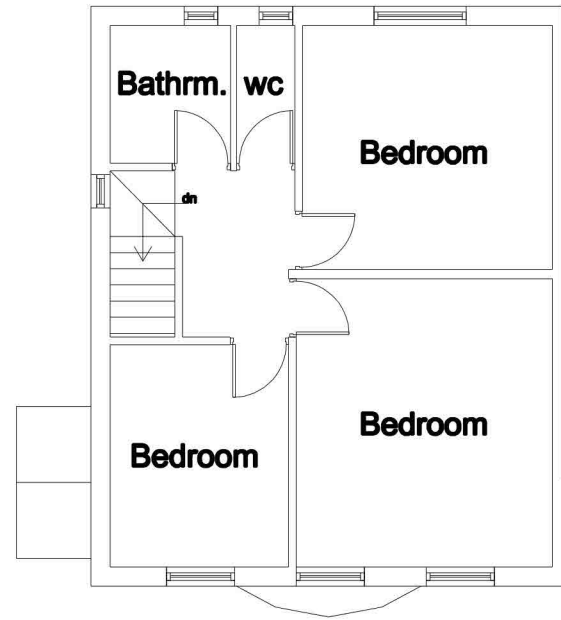


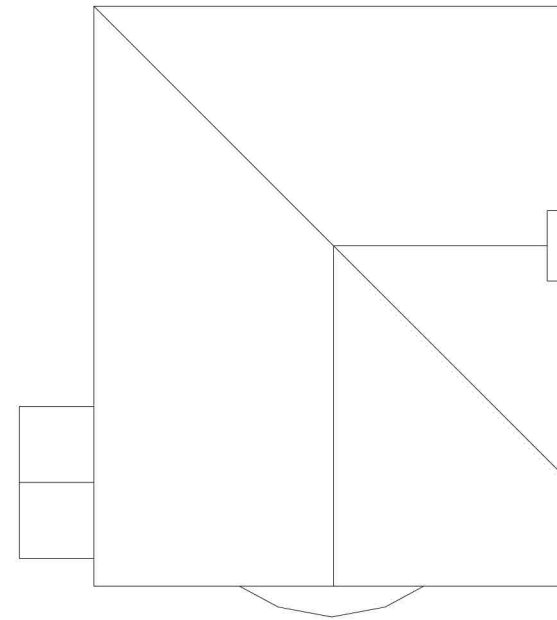

Existing Ground Floor Plan



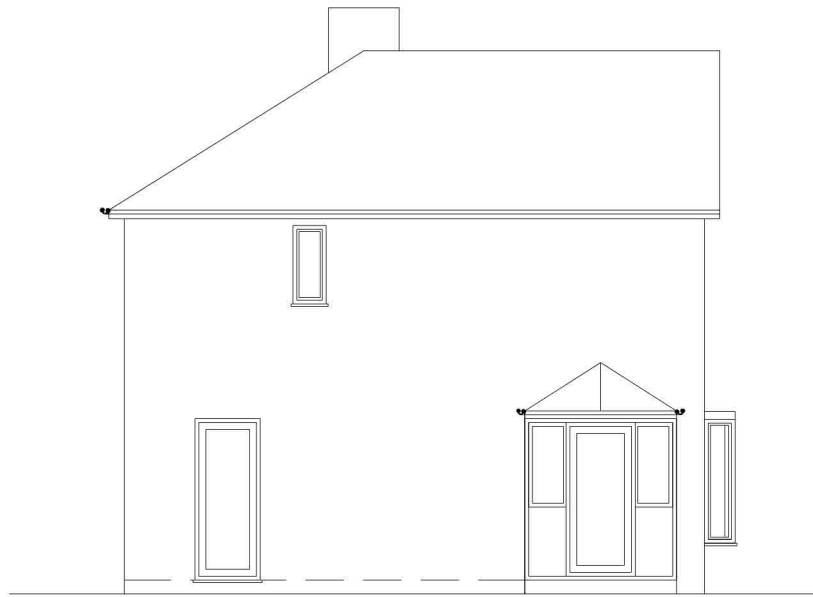
Existing First Floor Plan



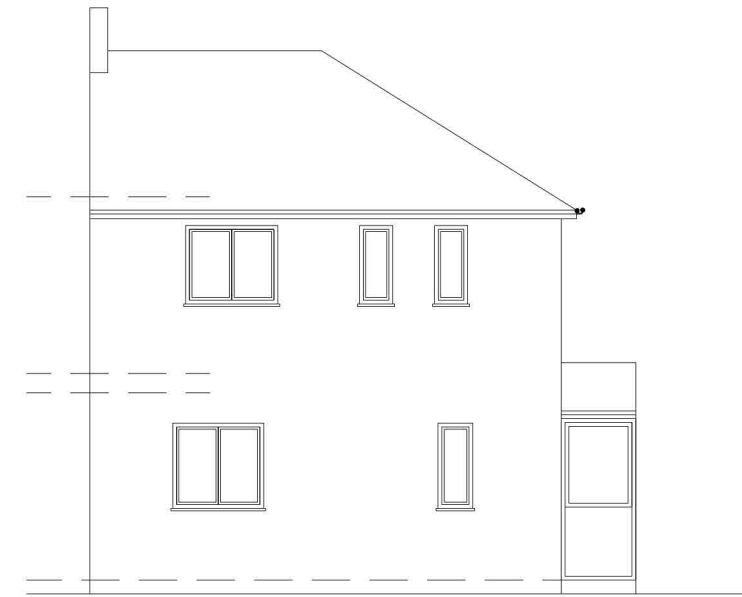
Existing Roof Plan



Existing Front Elevation



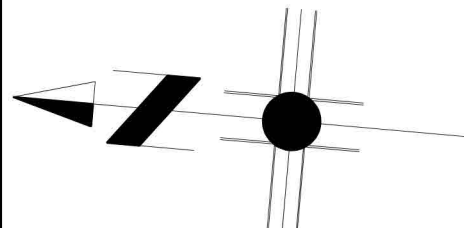
Existing Side Elevation
