3. The replacement signage will use the same fixing methods as the existing signage which includes:
Projecting sign: Existing project sign to be removed and replaced with new projecting sign, to be affixed with the same fixing methods - Panels secured over internal framework which projects through fascia panel, fixed back to building substrate.
Fascia panel: Existing fascia panel to be removed and replaced with new fascia panel, to be affixed with the same fixing methods - To be installed through existing granite and secured with Acrylic logo and lettering attached through mechanical fittings.
ATM surround: Existing ATM surround to be removed and replaced with new ATM surround, to be affixed with the same fixing methods - VHB Tape to bond sign to Glass.
Window message and Safety manifestation: Frosted vinyl internally applied to the window in 3M Crystal 7725SE-314 Dusted White.
