CHANGE OF USE FROM A SINGLE RESIDENTIAL UNIT (currently USE CLASS C3 dwellinghouse used as supported living home for one young person over the age of 16) TO ALSO ALLOW FOR USE AS CARE / SUPPORTED LIVING ACCOMODATION FOR TWO PEOPLE (USE CLASS C2) - with no physical or external alterations.

NB: It is intended to have 2 people (2 children, or 2 adults) in care and/or supported living, under Use Class C2. "Care" for Use Class C2 is defined as 'personal care for people in need of such care by reason of old age, disablement, past or present dependence on alcohol or drugs or past or present mental disorder, and Use Class C2 also includes the personal care of children and medical care and treatment'. This is within Article 2 of the Use Class Order 1987.

The care will be full-time members of staff (3) working on 8 hour shifts throughout the day, one on site at all times using the smallest of the three bedrooms at night. This is thought to generate only the most modest amount of activity and no more than already occurs at the site. PLANNING CONSIDERATION NOTE: It could be argued that there is no actual material change of use (and thus no development requiring planning permission as per s55 TCPA) with regards the proposed new operational use, nevertheless, the applicant requires a planning permission to be granted in the terms we have submitted in order to comply with OFTSED requirements. It will be for the local planning authority to determine whether the proposed new operational use as described here is acceptable under this application. Prima facie, it is considered the existing and proposed use will be very similar in the land use planning balance and thus therefore acceptable, notwithstanding any debate regarding whether there is development or not, or whether the new use falls in or out of Use Class C3 or is sui generis or another use class such as Use Class C2.

PLAN SUITE: As no changes, alterations or extensions are proposed to the property inside or outside, it is considered otiose to require site plans, floorplans and/or elevations as this is a simple change of use proposal with no physical changes or built development - hence a detailed site description, a site location plan at 1:1250 and a Google Street View image is solely attached to the submission which should more than suffice for assessment and consultation.
