This tree is a walnut that has sadly died. I have had Osh Gates of OG Organic Gardens Ltd come and diagnose what has happened. He thought that the position for the Walnut tree which I planted was too shady and now the tree has died, I had noticed the tree going downhill for several years.

I was going to replace the Walnut tree with a plum tree.

Trees 2 & 3

These trees are part of a pollarded Sycamore that has been undercut by the river. A few years ago a leg of one of this group of trees fell across the river and into my neighbours garden. My neighbours are having a shed built near to where the previous tree leg fell. I showed these trees to Osh Gates of OG Organic Gardens Ltd he also felt they were in danger of falling across the river.
