- T1-Acer Rubrum this tree is growing too large for its location and its canopy is encroaching on adjacent trees so we apply to reduce the crown by 1.5 meters.
- T2- Betula Pendula this tree has poor form and canopy due to it being to close to adjacent trees and has struggled for daylight so we apply to cut down this tree.
- T3- Prunus Cerasifera Nigra this tree is growing to tall so we apply to reduce the height by 2 meters to maintain a good shape.
- T4- Taxus Baccata this tree is growing too large for its location next to the driveway so we apply to reduce its height by 1.5 meters
- T5-Taxus Baccata this tree is growing too large for its location next to the driveway so we apply to reduce its height by 1.5 meters

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
