Removal of a large fir tree positioned on the left side of our enclosed rear garden. The tree has become too big for the garden and is creating excessive shade and ground dryness, which is affecting the growth and health of other plants within the garden area. It is our intention plant two smaller fruit trees (unsure of which species yet) in the same area of the garden once the fir tree is removed.
