The Alder at the bottom of the drive has become very large with multiple boughs and is located on the edge of a stream between our property and 2 Swallow Drive., We are concerned that the weight of the tree in its location will result in the tree falling at some time in the future. I have attached photos showing this and request that at least two boughs are removed to balance the tree and lessen the weight.
