T4 - Field Maple Suggested Works: Dismantle to near ground level.
Reason for works: T1 & T4 are small trees that have become misshapen and unsightly, T3 is starting to dominate the small garden. The suggested works are for the homeowner to gain back control over their garden and make it easier to manage.
