Trim back 6 Mature Oaks in 1289G1 to tertiary branching at previous trim (pre TPO,1990) on southern aspect (Chapel Road face). Reduce Crowns to 10m Height and northern aspect in proportion, Branches <55mm. Remove secondary branch from 1289T6 where it interferes with roof at rear of property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
