Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
Removal to ground level of Yew Tree (Taxus baccata) as marked with red X on attached site plan document (named 39 Bridge End Yew Tree). Photos of said tree from various angles attached (named Yew Tree 1,2 and 3). The tree has grown to over 5 metres tall and is unsuitable for such a small garden. If left unmanaged it will become even larger and overpowering for the location. We have tried for many years to prune and restrict the growth of this tree. Maintenance has now become too dangerous as the tree is situated in a steeply sloping rockery which makes it impossible to access all sides with a ladder. We are keen gardeners and actively maintain the many other trees and shrubs in our garden.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
