Large Oak (T10).

There is a very large oak tree on the boundary of my property. I am concerned about the size of the tree given the proximity to the property. In addition the tree is having a significant impact of the light in the garden and the condition of the grass due to being in continuous shade.

I purchased the house off plan in 2017 and I was not allowed to visit the property and/or location fully prior to purchase due to the building works. Whilst the property details did show the presence of the tree, it certainly did not show the size and extent of the canopy. It was absolutely impossible to see the impact that the tree would have. The tree also appears to have grown significantly over the past 7 years and puts large parts of the garden in shade for much of the day.

The tree is 10 metres from my property and is around 18 - 20 metres high. The canopy spans approximately 18 metres.

I would like to apply for permission to reduce the canopy by 25% whilst maintaining the health and aesthetic appeal of the tree.

Please note: I am identifying the tree as in my property as I believe they are on my deeds. I understand my neighbours also believe it is included on their deeds. In reality the tree forms part of the hedgerow which I believe is the border itself.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
