T1- Conifer, reduce height by 0.5m, from 4m to 3.5m.
T3- Top Holly from 10.5m to 7.5m. T4- Top Holly from 9m to 8m.
T5- Cut back laurel by 4m to give clearance from boundary.
T6- Reduce height of laurel to 4.5m from 9m.  T7- Cut back laurel over lawn by 3m (currently 8m high which will remain the same, 5m wide prior to the work).
