T2 Beech - Rubbing branch. Remove back to main stem

T3 Beech - Over-extended lateral. Cut back to branch union

T4 Row of Beech - Crown reduce to clear house by up to 4m, cutting to suitable branch unions

T5 White Horse Chestnut - Undertake a framework pollard to reduce the main stem height by 1-1.5m and shorten all branches by up to 6m. Tree to then be managed as a pollard and inspected regularly.

T6 White Horse Chestnut - Undertake a crown reduction of 3-4m to mitigate minor cavities and increased exposure to wind loadings. Retain tree as a significant landscape feature

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
