Rear of property. 1x silver birch. The tree has grown quite tall and slender it is a concern to the client as it is in striking distance to neighbouring buildings, due to the fact it is so tall and slim it does move significantly in high winds. I would like to request to do a crown reduction by removing approximately 1.5m on the overall canopy to reduce wind sail.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
