Sweet Chestnut - Rear Garden - Reference Tree #7 in report.

Tree shows some distress with weak and dead branches. North Norfolk Tree Services (Jeremy Cox 07503 885499) on site visit recommended a 25% reduction in overall tree dimension includes canopy and lift. Request to make subsequent reduction of canopy and general reduction to remove dead and weak limbs.

Pedunculate Oak - Side of house - Reference Tree #8 in report

Tree presents some danger to falling in the pubic road and/or proximity to the house, potential damage to house. Tree consistently drops significant branches of dead wood into the garden exhibiting distress. Arborist identifies "weak fork" at 1.3m height raising concerns over wind damage when tree in full leaf, and potential risk Request to reduce canopy and weak branches to remove weight from tree which causes risk during periods of high wind.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
