Tree line of approximately 10m high needs to be pruned back as they are becoming dangerous. Recent storms have brought down several

Tree line of approximately 10m high needs to be pruned back as they are becoming dangerous. Recent storms have brought down several large branches close to cars and residents. Also at least one dead tree to be removed. Pruning to be carried out to remove 1.5 metres from canopy. And 1 metre in lateral direction. Currently the trees are reaching out over vehicles which also causes hazard due to sap falling onto cars.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
