Remove 2 x holly and crown reduce remaining trees against wall to around 1ft above top of wall. Reduce smaller shrub crown by around 50% height and shape to ball. Photo attached to application as yard is locked and may not be accessible for viewing. Holly trees causing a nuisance and the rest just needs a good tidy. Not really visible from public domain.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:

 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
