Tree 1 is 15 metres wide and 18 metres tall approx. Yew Tree Crown lift to 4 metres Crown reduction over the northern garden perimeter by 1 metre Removal of epicormic growth and reshape

Tree 2 is 11 metres wide and 16 metres tall approx. Yew Tree Removal of epicormic growth Removal and tidying of previous non standard cuts (dead stumps)

Crown reduction of 1 metre up to 8 metres and reshape

The reason for the work to be carried out on T1 - there is a children's play area with wooden play equipment which is currently unusable due to low hanging branches and this area is totally overgrown and not accessible.

The reason for the work to be carried out on T2 is that it is providing limited light to the house and neighbouring properties. It is also impacting the flower beds to the rear of the cottage. To remove the epicormic growth and tidy up the unsightly work carried out by previously carried out by a gardener.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
