The Centre is used for Community activities. The main hall accommodates youth activities (e.g. brownies, cubs, scouts, guides), group meetings and clubs (e.g. bowls, friendship club, art group, fitness activities) and private bookings (weddings, children's parties). There is a stage in the hall in regular use by Ketton Players and for music events. There are kitchen facilities: there is a weekly cafe throughout the year and warm hub in winter. Regular bookings include Farmers Market and Haverhill Town Football Club. The Kedington Branch of Suffolk Libraries is housed in the building as are the Parish Council offices.

The Centre is situated in Great Meadow, a public recreation area managed, along with the Centre building, by the Kedington Community Association (registered charity). The proposed extension currently comprises part of Great Meadow adjacent to the existing Centre.
