One sycamore tree (S on attached sketch) close to southern boundary of back garden. I want to prune it back about 10ft to where it was last pruned.
One cherry tree (C1 on attached sketch) close to southern boundary and about halfway along garden. I want to prune this back by about 5 metres from top, to allow more sun over my vegetable plots

One cherry tree (C2 on attached sketch) near the middle of garden to prune back by 1 to 2 metres to allow more sun over my vegetable plots
