T01. Pine- Crown Reduce to give 3 metre clearance from property. To prevent damage to property and reduce chance of pest ingress into property

T02. Lime. Remove epicormic growth to allow better inspection of lower butress and stem

T03. Yew . Crown reduce 1-2 metres on eastern side. to reduce shading into property.

T11. Lime. Remove epicormic growth to allow better inspection of lower butress and stem

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ~$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
