- 1. 1 x Blue Atlas Cedar Reduce to old pruning points. Crown raise to 3 metres
- 2. 1 x Monterey Pine Remove to ground level and replant with a more suitable type of tree

Reason

tree number 1 - reduce to keep tree at a sensible size for its location.

tree number 2 - Remove due to tree growing too fast and large for its situation. Replant with more suitable type of tree.
