Having quickly reviewed the attached drawings, there was an additional drawing amendment request on drawing 4STE-EE-STO-01 (Garden Store) which has not been included.

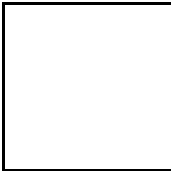
That said, the attached amended site plan (drawing STE-SP-01 REV D) now doesn't show/detail the Garden Store.
