Oak in rear garden - Reduce and reshape by 3m. The Oak is quite large for the garden and reduces the sun into the garden. There appears to be a history of previous pollard at a young age, suspect structural integrity for new growth that creates new crown.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
