## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1: 20% crown thin inclusive of epicormic growth and dead wood.

T2: 20% Crown thin inclusive of epicormic growth, dead wood and a 3 meter clearance of the property removing only secondary limbs back to appropriate growth points.

T3: We recommend immediate removal due to the extensive lean of the tree, it leans at roughly a 40 degree angle over the garden fence and has now become a danger to the public.

T4: 20% Crown thin inclusive of epicormic growth, dead wood and a 3 meter clearance of the property removing only secondary limbs back to appropriate growth points.

T5: 20% crown thin inclusive of epicormic growth and dead wood.

T6: 15% Crown thin inclusive of epicormic growth and dead wood.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

• indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:

- mark and name surrounding roads
- sketch in buildings, including adjoining properties
- add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
