New projection sign – The base will be a composite panel and composite frame, Olive Green Composite (4mm) background with gold mat colour letter. The light will come out of the letter – 4000lm warm light.

The existing Victorian awning will be replaced with a manual Slide Victorian Awning -Khaki Fabric R162.
