This document serves as information pursuant to the discharge of Condition 5(iii) to Planning Permission Ref. 21/06372/FULL and Condition 4(iii) to Listed Building Consent Ref. 21/07165/LBC.

This document supersedes the previously submitted document "2173(02)754 - TP 5 & LBC 4 External Metalworks_Rev C".

The following changes to the scheme have been included in this document:

The construction of the new Eaton Lane façade has changed from pre-cast concrete panels with an SFS backing to handset brickwork with and SFS backing. The changes related to this can be seen on the following drawings:

The doors to the UKPN room on Eaton Lane have been changed from a single door to a double door in line with UKPN requirements. This change can be seen on the following drawings:

The lift overrun to the east core lift has been slightly amended to correct a graphical error. The interface between the overrun and the mansard roof on Eaton Lane is lower than previously indicated. The overall massing of the overrun has not changed. This change can be seen on the following drawings:

Joints to the stonework panels on Eaton Lane have been added indicatively. These were not previously included but will be needed to ensure the scheme is buildable. This change can be seen on the following drawings:

The platform lift in the undercroft on Eaton Lane has been amended to show a glass-fronted lift rather than the stone-clad lift previously indicated. This follows further engagement with lift suppliers which has revealed that the stone-fronted lift is not feasible. This change can be seen on the following drawings:

The stairs to the rear entrance on Eaton Lane have been reduced in width to create more space for vehicles manoeuvring into the car lifts and reduce the risk of a collision with the stair handrails. This change can be seen on the following drawings:

The sills at the base of the inset brick panels on the Eaton Lane façade have been amended. Previously stone sills were shown under the windows but no sill indicated at the point where the brickwork steps out. The stone sills below the windows remain as before and a metal flashing has been introduced to the step in the brickwork. This change can be seen on the following drawings:

The spandrels to the windows and curtain walls were previously shown as white. These have been changed to reflect the design intent that they match the colour of the framing (Grey, RAL colour 7024). This change can be seen on the following drawings:
