The 3 x trees will be left as a balanced companion canopy away from the building which it is currently in contact with and away from the windows of the property. The vigour of the species gives the reason for what could be considered a hard prune but much less will not achieve aim and be clear of building for long. Not great tree species for location.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
