This application for tree work made on behalf of Mrs J Kamburoff of 18 Crossacres where oak tree in questions is bordering onto property.

Oak tree now overhangs across to 18 Crossacres roof line causing much debris especially during high winds with potential to causing damage to property.

Proposed tree work has been discussed and agreed with neighbor, Mr David Morgan of 20 Crossacres.

Tree Work To Be Carried Out As Follows:

From main tree trunk going upwards 3 main branches which spur into further limbs which overhang 18 Crossacres to be reduced.

1st branch which spurs into 3 further branches - The 3 branches to be reduced by 2m to 3m.

2nd branch which spurs into 4 further branches - The 4 branches to be reduced by 2m to 3m.

3rd branch which spurs into further branches - The 3 branches to be reduced by 2m to 3m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
