T1 Large Pine Tree located towards back of garden. The tree has forked some 20m up. We believe it is advisable to remove the large curved stem on the south east side in order to achieve better weight displacement and reduce wind loading which is considerable during heavy storms. This will better balance the tree visually without affecting its amenity in any way and will reduce likelihood of the tree being damaged in high winds with consequent risk to boundary hedges and trees of neighbours.

T2 Old Pear tree located towards middle of garden. The tree is in overall poor condition: the most northern of three main stems is entirely split and largely hollow to the crown break, from which it is now pulling away. It is our observation that the cracks have increased since last summer. We would not have chosen to fell this tree and we have tried to preserve it (see Works to Trees planning application ref 22/00251/TPO) however advice from the arborist is that it is not safe to work in this tree and there is a risk a large part of it will break away especially if leaves and any fruit are present. Therefore regretfully we seek permission to fell.
