T2 - Ash. Ash dieback. Fell. Plant Acer Japonicum as replacement.

T3 - Sycamore. Self seeded and causing excessive shading in garden. Fell. Plant Acer Japonicum as replacement.

T4 - Cherry. Poor condition. Decay in stem. Fell and replace with Prunus Kanzan.
